# The CNDH reiterates its desire for dialogue and invites the collectives to build among themselves a unified proposal that will allow to move forward

The National Human Rights Commission (CNDH) strongly endorses its commitment to dialogue as a means of resolving conflicts, and reiterates that it will exhaust it to extreme, but it will also continue to work in trustworthy compliance with its legal and constitutional mandate.

In the specific case of the appropriation of its facilities, since the CNDH became aware of the list of requests of the National Front "Ni Una Menos" (Not One [Woman] Less), the Collective Aequus Promoción y Defensa de Derechos (Aeqqus Promotion and Defence of Rights) and Bloque Negro (Dark Block) on the issue of feminicides and the struggle for women's rights, we have taken firm steps to meet the demands, we subscribe them as legitimate and, since most of them are public policy situations, we announce the development of a General Recommendation that will address the problems in a comprehensive manner. We offered openness to analyse and discuss its content with those groups, which has not been done to date; therefore, and incorporating the demands they have made publicly, we are ready, in accordance with our Rules of Procedure, for the review and adoption of this Recommendation by the Advisory Council, so that it can be issued at soon as possible. Thus, we hope to be completing the fulfilment of the petition forms, as we promised 48 days ago.

The CNDH invites the collectives that intervened in the seizure of our facilities to propose a structured scheme between them to have a joint dialogue, comprehensive and summing-up, and immediately establish a single table to work together for the cause of the Protection of Human Rights.

Open Forum for Dialogue: "Integral Health in the Face of the COVID-19"



The National Human Rights Commission (CNDH) virtually completed, in October, the Open Forum for Dialogue "Integral Health in the Face of the COVID\_19", organised by the Permanent Seminar on Human Rights and Culture, promoted by president Rosario Piedra Ibarra. In it, specialists, academics, human rights defenders, public servants and society in general spoke with a view to solving, through critical thinking, the problems that afflict the Mexican population.

Among the topics highlighted were the challenges faced in the field of comprehensive health and the improvements demanded by the public and private health systems, as well as the situation of different groups vulnerable to the COVID-19, such as the elderly; people living in poverty; with chronic diseases and immunosuppressed people; health as a human right and the future perspectives arising from current experience.

The Open Forum for Dialogue had a great participation of public in social networks, which presented particular cases and questions about the right to health, which shows the importance of society in the defence and pursuit of human rights.

#### The CNDH demands recognition of the Human Rights of the inmates of the CEFERESO No. 2, West, of Puente Grande

Facing the disincorporation of the Federal Centre for Social Reinsertion No. 2 (CEFERESO No. 2, Spanish acronym), West, of Puente Grande, in Jalisco —part of the Federal Penitentiary System— the National Human Rights Commission (CNDH), through its National Mechanism for the Prevention of Torture (MNPT, Spanish acronym), called for full recognition of the Human Rights of persons deprived of their liberty who will be transferred, so that they can serve their prison sentence in the penal institution closest to their home, as established by law..

The CNDH details in its request that the transfer must comply with the principle of Reservation of Law, established in Art. 18 of the Constitution, where was embodied the will of the Constituent Assembly to enshrine a "fundamental" right



to serve the sentence of imprisonment in the penitentiary closest to the home of the sentenced person, when has been convicted of lawbreaking other than organized crime and do not require special security measures.

#### The CNDH addresses a Recommendation to the CEAV for violating the rights of eight persons

The National Human Rights Commission (CNDH) directed the Recommendation 39/2020 to Andrés Carlos Vázquez Murillo, General Director of Federal Legal Counsel and Desk Officer of the Executive Commission for Attention to Victims (CEAV, Spanish acronym) for violations to human rights to Peaceful Free Demonstration and Dignified Treatment, omissions in the care of victims and improper exercise of public service, attributable to public servants of the CEAV in tort of eight persons.

Last February, two of the victims went to the CEAV facilities to demonstrate against the lack of attention of the officials of that Executive Commission, a demonstration which was subsequently joined by six other persons, with the result that the CEAV personnel ordered to close their access to the toilets and suspend the electrical energy service: these causes that one of the victims, who suffers from comorbidities, difficulty moving and visual impairment, defecate in his clothing. The National Human Rights Commission (CNDH) requests the authorities of the three Government's levels to prevent acts that violate the rights of the members of the Migrant Caravan. This Commission is attentive to persons in the context of mobility who left Honduras for the United States of America, and who can eventually enter Mexican territory on their journey.

This National Organism calls on public servants to perform their duties within the legal framework, and to prevent acts of difficult or impossible reparation from being carried out against expatriates. Therefore, it requests the National Institute of Migration (INM, Spanish acronym) to implement the necessary mechanisms to guarantee the safety, protection and care of migrants, through an orderly registration and, if appropriate, the provision of the required care and accommodation, in appropriate and dignified conditions.

Through its various Foreign Offices, the CNDH will be attentive to the development of the facts, and in monitoring respect for the rights of migrants, issuing the proper pronouncement in accordance with the law.

The CNDH, therefore recommended to the General Director of Federal Legal Counsel and Desk Officer of the CEAV to schedule the two victims and their families in the National Register of Victims, and provide them with medical and psychological care; collaborate in the complaint filed against the two public servants responsible for the human rights violations, and attach in their labour files a copy of the decision issued by the Internal Control Body of the CEAV<sup>1</sup>.

#### The CNDH emits a Recommendation to various authorities of the state of Chiapas for the violation of the human rights of three indigenous women

Derived from an appeal, the National Human Rights Commission (CNDH) pronounces the Recommendation 40/2020 to the General Attorney's Office, General Secretariat of Government, and Secretariat of Security and Citizen Protection of the state of Chiapas, as well as the Municipal Council of San Cristóbal de las Casas and the State Human Rights Commission of Chiapas.

On February 8, 2019, two human rights defenders filed a complaint with the local Human Rights Commission, in which they denounced the prevailing impunity in the feminicide of a girl, and the criminalization, arbitrary detention and torture committed against three indigenous women —including a teenager— by public servants of the State General Attorney's Office.



Therefore, this CNDH determined the insufficiency of the Recommendation issued by the State of Chiapas Human Rights Commission and, in order to guarantee integral reparation of damage, it calls on the authorities indicating to carry out a public act of recognition of institutional responsibility, through a public apology addressed to the aggrieved, who must also be registered in the State Registry of Victims and grant medical, psychological and thanatological care, as well as legal assistance.<sup>2</sup>

The CNDH investigates possible human rights violations of two women detained in Georgia, the United States, attributable to SRE and INM personnel



The National Human Rights Commission (CNDH) investigates possible human rights violations of two women, who apparently were subjected to medical malpractices when they were under detention in Irwin County, Georgia, in the United States of America, attributable to personnel assigned to the Ministry of Foreign Affairs (SRE, Spanish acronym) and the National Institute of Migration (INM, Spanish acronym), who committed possible acts or omissions by not providing assistance to the victims.

When interviewed by CNDH personnel, one of them specified that, once deported, she arrived at the INM offices, where institutional staff informed her that three days before she had undergone surgery and she needed medical attention, as she had much pain. However, she was only checked by a nurse, who treated her wounds and gave her a prescription to buy medications. Once the process was finished, they ordered her to get on a bus to her destination.

Due to the facts, both women filed a complaint with this National Organism, which will promptly follow up the investigation and support the victims.

## The CNDH tracks Mexicans facing the death penalty abroad

The National Human Rights Commission (CNDH) punctually monitors the procedural status of 53 Mexicans facing a death penalty sentence: two in China and 51 in the United States of America.

For this Autonomous Organism, the Right to Life is fundamental and indispensable for other prerogatives exercising, becoming the most valuable legal asset of the human being. In this sense, its safeguard extends to our compatriots abroad.

Within this framework, the CNDH joints the actions that the Mexican State undertakes to avoid the application of the aforementioned punishment, and considers it essential to undertake strategies to avoid the death penalty in Mexican cases that currently face a judicial process that could derive

in a sentence of this type, in order to guarantee the Rights to Life, Dignity, Bodily Integrity and Due Process.

On the other hand, the CNDH considers of great importance to assure the respect of children and adolescents' human rights by studying in depth the unconstitutional nature of some initiatives, such as the Parental Pin, which seriously undermine the best interests of this group.

In the exercise of its powers, this Autonomous Constitutional Organism ratifies its commitment to protect, defend and guarantee the human rights protected by the



constitutional and conventional legal order, in favour of those who constitute our native peoples in Mexico.\_

#### The CNDH demands the authorities of EDOMEX to guarantee due process to principles of presumption of innocence and minimum intervention in the case of activist Kenia Inés Hernández Montalván

The National Human Rights Commission (CNDH) demands that the authorities of the state of Mexico (EDOMEX) respect and secure due process in the case of defender Kenia Inés Hernández Montalván, coordinator of the "Zapata Vive" collective, who was arrested on October 18 —at around 8pm, in the municipality of Amozoc, Puebla— by members of the Ministerial Police attached to the General Attorney's Office of EDOMEX, in compliance with an arrest warrant dated August 3, 2020.

The CNDH considers it essential that the authorities of that federal entity, in the exercise of their public powers, grant the minimum guarantees of due process to all person subject to their jurisdiction, ensuring all the legal requirements that must be observed in the procedural bodies, so that every



individual can defend himself adequately against any act emanating from the State which may affect his legal sphere.

The CNDH issues precautionary measures to INM to protect the health of migrants housed in the "Siglo XXI" Migrant Holding Centre and the "El Hueyate" Temporary Stay, in Chiapas



The National Human Rights Commission (CNDH) issued precautionary measures to the National Institute of Migration (INM, Spanish acronym)) in view of the inadequate conditions in which persons are housed in the context of international mobility in the "Siglo XXI" migrant holding centre and the "El Hueyate" temporary stay, located in the state of Chiapas, as well as the lack of health measures to prevent and, where appropriate, mitigate the spread of SARS-coV-2 (COVID-19) among this population.

When attending that stay, this National Organism found that facilities do not have light and water services; hygiene conditions are inadequate and on-site accommodation is provided for other people, including women with their children who, despite having no COVID-19 symptoms, live with people whose diagnosis was positive for such a condition, without taking the necessary health measures to prevent contagion.

The CNDH requested precautionary measures from the SSPC of the state of Chipas for women deprived of their liberty, their children and the personnel of the Centre for Social Reinsertion No. 4, in Tapachula



Following a visit to the Centre for Social Reinsertion of Sentenced Women No. 4, Tapachula Femenil, in the state of Chiapas, the National Human Rights Commission (CNDH) requested to issue precautionary measures for women deprived of their liberty, their sons and daughters, and the personnel working in that prison, to the General Commissariat of the Secretary of Security and Citizen Protection (SSPC, Spanish acronym) of the State of Chiapas and the Chief Undersecretary for the Execution of Criminal sanctions and security Measures of the same federal entity, because of the danger to the physical integrity of these persons due to the poor infrastructure and unhealthy condition of the building.

Staff from this National Commission detected that the penitentiary has several leaks in different areas, such as bathrooms, and water escapes, electrical cuts, mold on some walls, and gas tanks in the corridors, as well as poor hygiene conditions and deterioration in rooms, kitchen, strainers and common areas, and a large amount of harmful fauna.

It was also verified that there is only one woman, a career doctor, who occupies the position of nurse, since when medical support is needed, the personnel of the Centre for Social Reinsertion No. 3, located in the same federal entity, is requested.

The CNDH addresses a recommendation to the OADPRS of the SSC for the death of a person in the CEFERESO No. 5 and the General Prosecutor's Office of Veracruz for the inadequate investigation of the case

The National Human Rights Commission (CNDH) addressed Recommendation 46/2020 to José Ángel Ávila Pérez, head of the Deconcentrated Administrative Organism Prevention and Social Rehabilitation (OADPRS, Spanish acronym) of the Secretariat for Citizen Security (SSC, Spanish acronym), for the inadequate care and attention given to a person deprived from liberty, who lost life in the Federal Centre for Social Rehabilitation No. 5 (CEFERESO No. 5, Spanish Acronym) located in Villa Aldama, Veracruz, and to Verónica Hernández Giadans, General Attorney of the entity, for the deficient investigation of the case.

After reviewing the evidence in file, the CNDH found violations on human rights to life, legal security, legality

and personal integrity of the victim by public servants of both units.

The CNDH addresses a recommendation to the Commissioner for Prevention and Social rehabilitation, for violations on the rights of 26 CEFERESO No. 6 inmates, in Huimanguillo, Tabasco

The National Human Rights Commission (CNDH) addressed Recommendation 48/2020 to the Commissioner for Prevention and Social Rehabilitation, José Ángel Ávila Pérez, for violations on human rights to dignified treatment, integrity and personal security, legal security and legality of 26 persons deprived of liberty in the Federal Centre for Social Rehabilitation No. 6 (CEFERESO No. 6, Spanish Acronym), in Huimanguillo, Tabasco, by actions and omissions of their custodial staff.

This made it possible to warn of the injuries present in the 26 victims were the result of the excessive use of force by five responsible authorities, without any data to refer to existence of their own manoeuvres of subjection and/ or subjection, or if they were inferred by other persons deprived of their liberty, in violation of article 13 of the Federal Centres for Social Rehabilitation Safety Manual, which states that when force is used it shall be recorded in the relevant minutes and shall be brought to the attention



of the competent authorities which are to intervene or take cognizance of the facts.

#### The CNDH issues a recommendation to the Secretary for Security and Citizen Protection, Alfonso Durazo, and the INM

The National Huamn Rights Commission (CNDH) issued Recommendation 50/2020 to the head of the Secretariat for Security and Citizen Protection (SSPC, Spanish acronym), Francisco Alfonso Durazo Montaño, and the Commissioner of the National Institute of Migration (INM, Spanish acronym), Francisco Garduño Yáñez, as a result of the attacks that the personnel of both institutions inflicted on members of the Migrant Caravan that entered the national territory in January of this year.

By allowing elements of the National Guard to carry out migratory review and detention of persons in the context of mobility, the INM violated the rights to legality and legal security of victims. In addition, the arbitrary or disproportionate use of force represented a violation of



the right to legality and personal integrity. Likewise, said authorities failed to safeguard the best interests of children and adolescents who were part of the migrant Population.

## International Cooperation Actions in Defence of Human Rights



#### **EXECUTIVE SECRETIARAT**

With the objective of promoting and strengthening the culture of human rights in Mexico, as well as maintaining a permanent link and joint work with the international community, the National Human Rights Commission (CNDH), through its Executive Secretariat, encourages and strengthens relations with public, social and/or private international organizations; it updates, analyses and participates through studies on international treaties and agreements according to its attributions, in addition to upholding a communication strategy close to the national and international population, to stimulate through the coordination of diverse mechanisms the broadcasting of these activities.

NETWORKING AND COLLABORATION WITH UNITED NATIONS (UN) SYSTEM AGENCIES AND THE INTER-AMERICAN HUMAN RIGHTS SYSTEM (OAS)

## UN Committee on the Elimination of Discrimination Against Women (CEDAW)

The CNDH delivered, to the president of the CEDAW, the alternate mid-term report on the Final Observations of the Committee on the Ninth Periodic Report of Mexico, as well as its Executive Summary, authorizing subsequently its publication on the CEDAW website.

Through the Executive Secretariat, the CNDH participated in the training workshop of the Inter-American System for

#### Newsletter - october 2020

Monitoring Recommendations (SIMORE Interamericano, Spanish acronym), organized by the Section on Impact and Follow-up on Recommendations of the Inter-American Commission on Human Rights (IACHR), with the participation of the president and public servants of the IACHR, as well as representatives of various national human rights institutions of the American continent.

The Update for the Year 2020 of the Inter-American Commission on Human Rights (IACHR) was sent to the CNDH's Executive Secretariat. In addition, the international agency was requested to set up the SIMORE Interamericano account for the General Directorate for International Organisms of the aforementioned Secretariat, as well as the request for experts who could assist in the practice of the study called *Istanbul Protocol*, in favour of A1 and B1, prosecuted in criminal case 100/2015 and its accumulated 290/2015-V.

## GLOBAL ALLIANCE OF NATIONAL HUMAN RIGHTS INSTITUTIONS (GANHRI)

Through its General Directorate for International Organisms, the Executive Secretariat responded to the GANHRI's survey *National Human Rights Institutions and COVID 19,* and participated in the Extraordinary General Assembly of the Global Alliance, where the Ombudsman of Ecuador was elected as president, along with the new members of the bureau.

#### NETWORK OF NATIONAL INSTITUTIONS FOR THE PROMOTION AND PROTECTION OF HUMAN RIGHTS IN AMERICAN CONTINENT (RINDHCA)

The Executive Secretariat, through its General Directorate for International Organisms, participated virtually in the preparatory meetings of the forum Advances and Challenges on the Implementation of the Constitutional Block and the Control of Conventionality as a Mechanism to Enforce the Respect and Guarantees of Human Rights, which was also attended by the Technical Secretariat of the Network of National Institutions for the Promotion and Protection of Human Rights in American continent (RINDHCA, Spanish acronym).

#### **IBERO-AMERICAN OMBUDSMAN FEDERATION (FIO)**

Communication was established by e-mail with the coordinator of the Office of the National Ombudsman for Migrants of the National Commissioner for Human Rights of the Republic of Honduras (CONADEH, Spanish acronym), to clarify the situation of the departure from San Pedro Sula, Honduras, of the new migrants caravan bound for the north of America, and to request that interactions regarding the activation of the Procedures Protocol of the Ibero-American Ombudsman Federation (FIO) for the protection of persons in the context of migration, to hereinafter be addressed to the Executive Secretary and the General Director for International Organisms.

In the same way, a response was sent to activate the protocol so that the CNDH could provide support once the Group of approximately six hundred Hondurans who started the migrant route enters Mexican territory.

#### **NATIONAL HUMAN RIGHTS INSTITUTIONS (NHRI)**

The CNDH, through its Executive Secretariat, committed to support the Hu7man rights Procurator of Guatemala and the Ombudsman of Ecuador for their participation in the international symposium *Strategic Topics in Human Rights from an Ibero-American Perspective*, as well as contributing to the update of the Agenda for this symposium.

#### LINKING AND COOPERATION ACTIONS

The request of the General Directorate for Human Rights and Democracy of the Ministry of Foreign Affairs on the petitions P-382-14, P-542-17 y P-548-16, currently before the Inter-American Commission on Human Rights (IACHR), was answered.

#### **TOPICS ADDRESSED BY THE DIRECTORATE ON INTERNATIONAL NGOs**

#### OCTOBER 2020

The Directorate of International Non-Government Organizations (NGOs) monitors on daily basis the activities of more than sixty civil Society organizations dedicated to the promotion and protection of human rights. As a result, a weekly systematization is carried out, in which all documents issued by these NGOs are index, highlighting the human rights violations of vulnerable populations of greatest concern, and those related to the COVID-19 pandemic. In addition, these pronouncements are recorded linking them to the violated rights protected by each of this CNDH's Visitation Offices, among other areas.

## **Action of Unconstitutionality**

#### October 2020

In accordance with Article 105, Section II, Item g) of our Fundamental Canon, the President of the National Human Rights Commission (CNDH) has the constitutional power to promote actions of unconstitutionality before the Supreme Court of Justice of the Nation (SCJN) against general rules, such as laws issued by the Congress of the Union or local legislatures, as well as international treaties, which may infringe on the essential rights of individuals. In October 2020, the publication of **137** regulatory changes issued by the legislative bodies of the federal entities and the Congress of the Union was detected, as shown in the following graphic —where the number of general rules detected during that period is identified—.



The head of the CNDH decide to exercise her legislative power to promote actions of unconstitutionality before the SCJN on four occasions during October 2020, thus presenting **4** lawsuits against the same number of general rules that were detected in the newspapers and governmental gazettes in four different states. These claims were filed against the following legal systems:

- Coahuila: 1 (*Political Constitution of the State of Coahuila de Zaragoza*), that initiated an action of unconstitutionality pending filing. 285/2020
- San Luis Potosí: 1 (Law for the Inclusion of Persons with Disabilities in the State and Municipalities of San Luis *Potosí*), that initiated the action of unconstitutionality 274/2020.
- Sinaloa: 1 (Sinaloa State Anti-Corruption System Law), that initiated the action of unconstitutionality 275/2020.
   Tabasco: 1 (Tabasco State Judiciary Organization Organic Law), that initiated an action of unconstitutionality pending Settlement. 277/2020
